TOURNAMENT RULES

- Fishing will be for two day (Saturday & Sunday, August 13-14, 2011) from the Rogers City Small Boat Harbor. Boat inspections will begin at 5:00 A.M. Boats will be released from the Harbor in order of registration. All boats shall be back inside the Rogers City Small Boat Harbor break wall by 7:00 P.M. Saturday and by 2:00 P.M. Sunday. (In case of inclement weather, prizes will be determined by drawing from the registered boat Captains at 2:00 P.M. Sunday August 14, 2011. **Inclement weather shall be defined as the posting of a SMALL CRAFT WARNING by the U.S. Coast Guard for Northern Lake Huron.**)
- Boat Registration materials and the latest Tournament updates will be available at the Rogers City Small Boat Harbor on Friday, August 12, 2011 between 12:00 noon and 4:00 P.M. or will be presented to the Boat Captain at the time of Boat inspection.
- There are no tournament boundaries.
- Channel 07 is the official tournament channel and all boats must have an operating VHF Marine radio.
- All tournament participants are expected to follow Michigan DNRE rules and regulations. Tournament officials reserve the right to disqualify any participant or boat for unsportsman like behavior, drunk or disorderly conduct, or inappropriate language.
- The winner of this Tournament will be the boat with the greatest total weight of one persons daily limit, each day per boat, of Great Lakes Salmon and/or Trout, chosen by the Captain or his designee.
- Prizes will be awarded immediately following the completion of the weigh-in Sunday. Prize monies will be presented to the Boat Captain.
- In the event of a tie in weights, the winner will be determined by the largest single fish.
- No boat may come in direct physical contact with the shore or another boat. Physical contact with the shore or another boat during fishing hours will result in disqualification unless tournament officials determine that there is an emergency.
- Protests must be accompanied by a \$250 cash deposit and must be registered in writing to tournament officials no later than 5 minutes after the last fish is weighed-in. If the protest is upheld the deposit is refunded, if the protest is not upheld the deposit is forfeited.
- Registrations should be received by August 12, 2011. Late registrations will be accepted from 12:00 noon until 4:00 P.M. Friday, August 12, 2011 at the Rogers City Small Boat Harbor and any questions about tournament will be answered.
- Withdrawal from the Tournament with 50% refund must be received by Tournament Officials by August 8, 2011.
- All tournament participants must have a signed Tournament Participant Agreement on file with Tournament Officials prior to fishing. Participant Agreement Forms will be available Friday afternoon, August 12 or at Boat Inspection on August 13.
